Fabrorb serves not only to attenuate sound but also to enhance the thermal characteristics of fabric roof systems.

Fabrorb materials are translucent, non-burning, porous composites based on fiberglass and PTFE.

All SHEERFILL® membranes conform to rigid fire and building codes for permanent structures.
